





# **ICMA Student Chapters**

#### Goals:

- Introduce and integrate students into local government management
- Familiarize students with ICMA members, resources, and the Code of Ethics.
- Establish connections between ICMA, schools, students, state associations, and managers.



# What can you do?

#### Start a student chapter!

- No fees: costs are now underwritten by ICMA-RC
- Become the student chapter's management advisor

#### Teach a course

- Invite student groups to facilities tours, site or training demonstrations
- Help fund student professional development (memberships, conference scholarships)



# **Recruiting Emerging Leaders**

Share the benefits of belonging to ICMA with your department directors and emerging talent:

- Department Directors: New flat dues rate of \$200 for affiliate members
- Emerging Leaders: Tiered rate of \$150/year 1, \$175/year 2, and capped at \$200





# ICMA's National Coaching Program

- ICMA-RC is underwriting the national coaching program.
- Building on the success of Cal-ICMA to launch the national program.
- Critical for providing support to emerging leaders and building diversity in the profession.
- Utilizing Cal-ICMA's director of coaching to make this happen.
